Freight/Shipments within Canada - Terms and Conditions

The Moving & Shipping Centre commits:

- ❖ To transport to its final destination.
- ❖ To serve to the client and to provide the information related to all its shipments.
- ❖ To maintain the quote for a term of 30 days.

Declaration of Contents

- ❖ The sender is responsible to declare the shipment content.
- ❖ The sender is responsible to attached to the cargo a commercial invoice and the packing list.
- ❖ If the content of shipment is not satisfactorily declared in its totality, the sender will incur additional charges.

Insurance and Responsibility for Commercial Cargo

- ❖ Subject to the limitations set forth herein and as provided by applicable law MOVING & SHIPPING CENTRE's agrees to pay for loss or physical damage to the described shipment(s) which may be caused by its negligent or wilful conduct. Where shipments have declared values, MOVING & SHIPPING CENTRE's liability for shortage or damage shall be prorated by weight when part of a shipment is lost or damaged. Otherwise, MOVING & SHIPPING CENTRE's liability shall be determined by multiplying the weight of the lost or damaged article by fifty cents (\$.50) per pound. All claims shall be filed within two (2) weeks of pick-up or shall be barred. Unless otherwise agreed to in writing, the maximum liability for shortage or physical damage shall be fifty cents (\$.50) per pound. If the declared value of the shipment exceeds fifty cents (\$.50) per pound, an insurance surcharge of ninety cents (\$.90) per One Hundred Dollars (\$100.00), or portion thereof, excess value shall be assessed. Neither MOVING & SHIPPING CENTRE nor the carrier(s) retained by it shall be liable for damages in excess of Three Thousand Dollars (\$3,000.00) per shipment, regardless of the value declared. Shipper understands and agrees that the rates do not include insurance or other compensation for loss, other than as expressly provided herein and limited hereby. Accordingly, Shipper agrees that in the event it desires coverage for loss, it will obtain insurance, and that said insurance will contain a waiver of subrogation clause waiving any subrogation rights for and on behalf of such insurance carrier. In the event Shipper fails to obtain a waiver of subrogation, Shipper will defend, indemnify and hold harmless MOVING & SHIPPING CENTRE and any carrier retained by it with respect to claims made by Shipper or third parties acting as subrogates of Shipper. MOVING & SHIPPING CENTRE shall not be liable for damage caused by force majeure, Act of God, or the inherent vice of the shipment.

Insurance and Responsibility for Personal Belongings

- ❖ Nor MOVING & SHIPPING CENTRE, neither its associate companies will cover or extend any type or insurance for any loss or physical damage to shipment(s) including personal belonging. Shipper understands and agrees that the rates do not include insurance or other compensation for loss and damage or delays. Accordingly, Shipper agrees that in the event it desires coverage for loss, it will obtain insurance, and that said insurance will contain a waiver of subrogation clause waiving any subrogation rights for and on behalf of such insurance carrier. In the event Shipper fails to obtain a waiver of subrogation, Shipper will defend, indemnify and hold harmless MOVING & SHIPPING CENTRE and any carrier retained by it with respect to claims made by Shipper or third parties acting

Time of Delivery

- ❖ THE MOVING & SHIPPING CENTRE had signed agreements with local & national cargo couriers, freight forwarders companies & airlines in order to provide the most secure and expedited service. Though, THE MOVING & SHIPPING CENTRE will not be responsible by any delays caused by third parties, airlines, carriers, natural disasters or customs authorities' delays.

Packing

- ❖ The sender is completely responsible for the ensuring that its cargo has been packed right and strong that ensure its contents from any damage or rip while handle and shipped.
- ❖ THE MOVING & SHIPPING CENTRE will not be responsible for damages by deficiency in the packing for the merchandise.

Storage

- ❖ The cargo must be picked up and clear from all charges and authorities within the next three (3) Business days after the arrival of the cargo. A fee of \$15,00 per each 100 Lbs Up to \$175,00 per Day will be charge initiating the Fourth (4) day is the cargo has not been retrieve from the warehouse. Temperature controlled service is not provided.

Term of Payment

- ❖ All Shipments without exception must be pay previous the pick up schedule. Additional fees not cancelled may be retained and will be a charge of a daily storage in the city of destiny was received.
- ❖ In case of re-evaluations of weight and size; additional charges must be cancelled to delivery of final destination.
- ❖ THE MOVING & SHIPPING CENTRE will charge \$45.00 CAN for any bounce cheque returned by the bank with insufficient funds (NSF)
